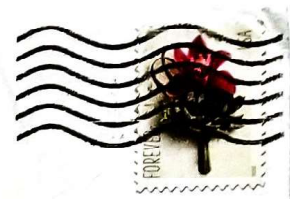

Hello All,

I am writing this open letter to document the seriousness of what transpired during a Bingo (Campaign) gathering held this evening, March 27, 2024, at 6:00 PM at Bermuda Club Condominiums Ballroom. I feel it is imperative to let Bermuda Club Leadership, NGMA Management, City of Tamarac elected officials and BSO public relations liaison to be aware of what happened leading to and during the event. The seriousness of disregarding Bermuda Club "Rules & Regulations" is completely unacceptable. **Most critical is the liable and unacceptable self-serving accusations that were said during the meeting.**

Mr. Marlon Bolton, no one said anything or prevented you from holding a gathering at Bermuda Club. The issue was the posting of your flyers on our Community Bulletins' Boards for the second time. Posting anything, anywhere, on our community property without prior written approval of the Council is a violation of our "Rules & Regulations, 19 and 22". The first event was dated February 28, 2024, at 6:00 PM, when then the flyer was formally removed by the previous manager. The second event was dated March 27, 2024, at 6:00 PM, at which the current manager chose not to get involved. To make matters even worse, you and your surrogates were hanging your flyers on our Condos' doors in all 27 Buildings. When I personally told you we have **No Solicitation Signs** posted throughout our community, you said that does not mean anything for political and religious flyers posting. It was very disturbing when you told me Bermuda Club is not a gated community, and it does not have a fence, therefore, you can simply walk in and post whatever you want on our doors.

To yell to the gathering crowd that I was taking photos of you at night is way beyond the pale and unacceptable behavior. This time around, your deception and lies are documented and will not be forgiven or forgotten. Who you invite or what you discuss or celebrate at Bermuda Club facilities is welcome and no one will ever prevent you from enjoying your livelihood and our accommodating community facilities.
